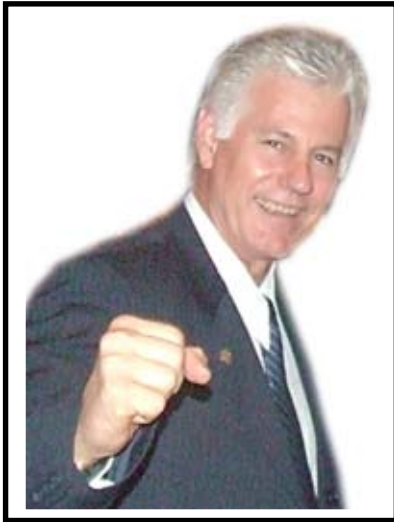

What is Martial Arts Recognition ? and WHO is doing the RECOGNIZING ? and are they of enough EXPERIENCE to do the RECOGNIZING ?

BOTTOM LINE IS

Your Martial Arts recognition is entirely ‘relevant’ to the ‘Master doing the recognizing’ or the ‘Board of Masters’ that sign your Martial Arts Certificate.

**Of course then you have the POLITICS and the COMMERCIAL ART VERSES the TRUE MARTIAL ARTS
You have Instructors that have 6th and 7th Dans and couldn’t ‘blow out a candle’
and may have been promoted for ‘political’ reasons or because they have PAID A FEE over the ‘internet’.**

IT IS ALL RELEVANT COMPLETELY .

**I remember when I was convincing the ‘old generation’ ISDA instructors
(Who were mainly INDEPENDENT INSTRUCTORS who had left the ‘traditional Systems’ many years ago)
What their actual Dan Ranking SHOULD BE RELEVANT TO INTERNATIONAL STANDARDS
If they had stayed in a ‘traditional school & one system’
Their MIND SET was hard to change into accepting they were actually MASTERS of their own ARTS
Their FEAR WAS What would the OTHER MARTIAL ARTS SCHOOLS SAY ?
My answer was WHAT OTHER SCHOOLS ?**

**WHEN YOU EXAMINE TRADITIONAL SCHOOLS THE ORIGINAL MASTERS ARE QUITE OFTEN
SELF APPOINTED or FOUNDERS OF THEIR PARTICULAR SCHOOL
AND SIMPLY RECOGNIZED BY THEIR OWN STUDENTS & SYSTEM
This is the KEY fact in every Martial Art School .**

HOW DOES ISDA Pty Ltd DO RECOGNIZED PRIOR LEARNING R.P.L. CERTIFICATION ?

**Firstly within my own school Healys’ freestyle Tae Kwon Do & Boxing Academy I am the Recognized 7th dan
Master of my own system and style as the Founder & Creator of the Healy’s System.

High ranking Black Belts , Boxing Champions , Lawyers, Businessmen and Students.
In my case 20 people in all Voting 100% to RECOGNIZE & PROMOTE me to the Master of my own School.
Also I used the INTERNATIONAL ITF Grading Standards relevant to Dan Grades and Timelines to balance
my experience, background & time training for comparison purposes refer ([Dan Grading ITF schedule](#))**

HOW DO YOU RECOGNIZE IN REALITY ?

My Grandfather and father were MASTER BOXERS

HOW DID THEY RECOGNIZE ?

Simple they would Look at you work out on the PUNCHING BAG !
and within 2 minutes they would know if you could punch and 'know your stuff' and what Standard you were

IN A PRACTICAL SENSE I USE THE SAME METHOD TODAY

EXAMPLE :

One of my new 'trainee black belts' come to me from a well known Karate Style with all the
AUTHENTIC JAPANESE CERTIFICATES

All looked 'Very Impressive' until I asked the Student to show me some combinations
on the punching Bag 'hands' & Feet' within 2 minutes I realized the Black-Belt

a) Had 'No Idea' how to punch effectively

b) Although 'very flexible' could not 'Power kick the Punching bag' with accuracy especially back Kicks and
any Turning and spinning movements

LESSON NUMBER ONE

practicing in 'the air' all the time in the 'traditional' 'mass production' way gives the student a
FALSE SENSE OF REALITY AND NO REAL DEPTH ESPECIALLY HITTING POWER

LESSON NUMBER TWO

I then demonstrated what we Do and how we do it

(by demonstrating punching combinations and kicking combinations on the Bag Myself)

Immediately the Karate student admitted their shortcomings

And I started retraining them

HOWEVER , I DID HAVE A GOOD FOUNDATIONAL BASE TO WORK FROM

So I SIMPLY HAD TO DO 'FINE TUNING'

This is typical of many of the students from 'all different styles and backgrounds' that come into Healy's
freestyle Tae kwon Do & Boxing Academy

I TAKE THEM WHERE 'THERE ARE AT' AND BUILD FROM THERE

ISDA PTY. LTD. (RPL) RECOGNIZED PRIOR LEARNING RECOGNITION IS EXACTLY THE SAME

Based on your background and 'demonstrated' ability

c) a written Historical overview (written by yourself) of your history, background and philosophy

REMEMBER the Martial Arts certification is only relevant to your particular ART

In the final analysis of a ISDA Pty Ltd RPL (Martial Arts) Certification there will be a relevant
'Testing Board' Signing off on your RPL ISDA CERTIFICATION relevant to YOU and what you know
My Area's of expertise are Boxing & Tae kwon Do so my signature on an ISDA RPL 'hold weight' in those
areas , other signatures on the Certification are completely relevant to 'other aspects' of Martial arts' for which
you wish to be 'recognized in' and are 'personally happy' with the process.

At the end of the day 'its only a 'piece of paper' and only has relevance if you
believe it has and have faith in the INTEGRITY of those doing the RPL (ISDA)

FURTHER ISDA RECOMMENDATIONS

we also recommend that you complete the Sports Coaching Certificate (4)

For Senior Instructors this can be achieved with a 8 day MASTER CLASS

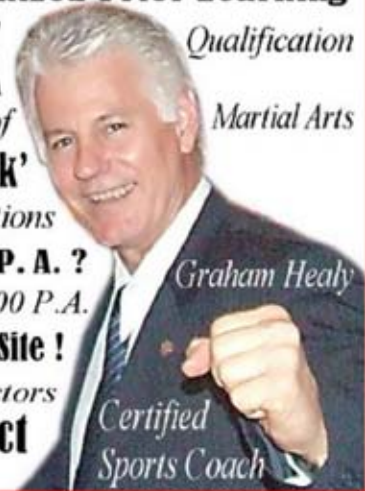
